Thank you for your interest in showcasing our film *Proving Up & Settling Down*, on your website.

I read through your website and feel I need to let you know that, though we are entirely sympathetic with the struggles of indigenous people worldwide, we are not indigenous. That being said, however, we have produced and directed about a dozen films, whose main subjects and characters are indigenous -- primarily from the Pacific Northwest.

Proving Up & Settling Down is a film that examines the lives of people, who chose the remote Hells Canyon country as their home. It begins with the story of Chief Joseph, as told by Horace Axtel, the grandson of a member of Joseph's Band of Nez Perce. That sequence in the film is considerably shorter than we had wished it to be, but necessarily so in order to move the main story line ahead. This film has been well received at several film festivals in the U.S. and in Europe.

A previous film, *The River Has Many Stories*, which also includes Hoarace Axtel, examines Hells Canyon as an indigenous cultural site and is a call for the preservation of the more than 8,000-year aggregation of cultural materials that may be found in the 70-mile-long stretch of this nearly inaccessible canyon.
